#### **STAFF RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

- 1. In Case No. TA-99-115, the Commission granted The Pager Company certificate of service authority to provide basic local and local exchange telecommunications services.
- 2. In Case No. TO-2002-165, the Commission acknowledged the addition of a fictitious name, i.e., The Pager Company d/b/a The Pager & Phone Company.
- 3. On December 15, 2006, The Pager Company d/b/a The Pager & Phone Company filed adoption notices and revised tariff title sheets, with a proposed effective date of January 17, 2007, to reflect its change of corporate name to YourTel America, Inc. Tariff File No. YC-2007-0418 contains the filings for the company's MO P.S.C. No. 1, Local Telecommunications Services tariff. Tariff File No. YC-2007-0419 contains the filings for the company's MO PSC No. 2, Competitive Telecommunications Access Services Tariff.
  - 4. Commission rule 4 CSR 240-2.060 provides:

(5) A name change may be accomplished by filing the items below with a cover letter requesting a change of name. Notwithstanding any other provision of these rules, the items required herein may be filed by a nonattorney. Applications for approval of a change of name shall include:

(A) A statement, clearly setting out both the old name and the new name;

(B) Evidence of registration of the name change with the Missouri secretary of state; and

(C) Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application.

5. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Commission recognize the new name. The application clearly sets out the old name of The Pager Company d/b/a The Pager & Phone Company and the new name of YourTel America, Inc. The application includes evidence of registration of the name change with the Missouri Secretary of State. The application includes an adoption notice and revised title sheet for each of the referenced tariffs.

6. Pursuant to 4 CSR 240-3.545(20), the application also includes a copy of the notice of the name change that the company will deliver to its customers on or before the next billing cycle.

WHEREFORE, the Staff recommends that the Commission issue an order to recognize the name change of The Pager Company d/b/a The Pager & Phone Company to YourTel America, Inc., and to approve the adoption notices and revised tariff title sheets.
