ORDER GRANTING EXTENSION OF TIME

On August 20, 2026,¹ the parties were directed to submit a proposed procedural schedule or status report no later than August 28. On August 28, Ameren Missouri, on behalf of all parties, filed its *Status Report* which requests and extension of time to file a proposed procedural schedule.

The *Status Report* states that the parties are making progress on developing a proposed procedural schedule, and requests an extension of time for the parties to file a proposed procedural schedule, or an additional status report, until September 4.

The Commission finds the requested extension to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

- 1) Ameren Missouri's request for an extension of time is granted. The parties shall submit their proposed procedural schedule, or an additional status report, no later than September 4, 2026.
- 2) This order shall be effective when issued.
