ORDER RECOGNIZING NAME CHANGE

Effective Date: March 2, 2022

On February 1, 2022, Inteserra Consulting Group (Inteserra), on behalf of its client, Matrix Telecom, LLC d/b/a Matrix Business Technologies (Matrix), filed a notice of name change to Lingo Telecom, LLC d/b/a Lingo and an adoption notice for Tariff No. 9. On February 14, 2022, on behalf of Matrix, Inteserra filed a tariff adoption notice for Tariff No. 4. The tariff adoption notices both bear an effective date of March 2, 2022.

The Staff of the Commission (Staff) filed a recommendation on February 15, 2022, advising the Commission that the notice of name change complies with the Commission's requirements for a name change and recommending that the Commission recognize the name change. No one has opposed the name change.

The Commission has reviewed the notice of name change, the tariff adoption notices, and Staff's recommendation. The Commission will recognize the name change and allow the adoption notices to become effective by operation of law.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the change of name of Matrix Telecom, LLC d/b/a Matrix Business Technologies to Lingo Telecom, LLC d/b/a Lingo.

2. The tariff sheets filed on February 1, 2022 and February 14, 2022, assigned Tracking Numbers JC-2022-0217 and YC-2022-0221, respectively, shall be allowed to go into effect by operation of law on March 2, 2022. The tariff sheets are:
