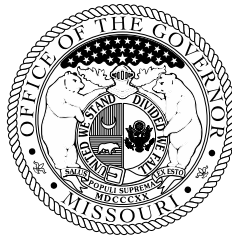

PROPOSED AMENDMENT

20 CSR 4240-20.030 Uniform System of Accounts—Electrical Corporations. The Public Service Commission is amending the rule purpose, sections (1), (3) and (4), and subsection (2)(B).

PURPOSE: This amendment updates citation references from the originally filed rule of 4 CSR 240-3.160 and 4 CSR 240-3.175, which were moved on August 28, 2019, and subsequently rescinded and placed into one new depreciation rule. The rule was also revised to update references to the current year for the Uniform System of Accounts (USOA) and remove other dates no longer needed.

*PURPOSE: This rule directs electrical corporations within the commission's jurisdiction to use the uniform system of accounts prescribed by the Federal Energy Regulatory Commission for major electric utilities and licensees, as modified herein. Requirements regarding the submission of depreciation studies, databases and property unit catalogs are found at [4 CSR 240-3.160 and 4 CSR 240-3.175] **20 CSR 4240-10.200**.*

(1) [Beginning January 1, 1994, every] **Every** electrical corporation subject to the commission's jurisdiction shall keep all accounts in conformity with the Uniform System of Accounts Prescribed for Public Utilities and Licensees subject to the provisions of the Federal Power Act, as prescribed by the Federal Energy Regulatory Commission (FERC) and published at 18 CFR Part 101 [(1992)] **(2026)** and 1 FERC Stat. & Regs. paragraph 15,001 and following [(1992)] **(2026)**, except as otherwise provided in this rule. This uniform system of accounts provides instruction for recording financial information about electric utilities. It contains definitions, general instructions, electric plant instructions, operating expense instructions, and accounts that comprise the balance sheet, electric plant, income, operating revenues, and operation and maintenance expenses.

(2) When implementing section (1), each electrical corporation subject to the commission's jurisdiction shall—

(B) Assemble *[by July 1, 1996,]* and maintain *[after that,]* a property unit catalog which contains for each designated property unit, in addition to the provisions of Part 101 General Instructions 6. and paragraph 15,016—

1. A description of each unit;
2. An item list; and
3. Accounting instructions, including instructions for distinguishing between operations expense, maintenance expense and capitalized plant improvements.

(3) Regarding plant acquired or placed in service after *[1993]* **2026**, when implementing section (1), each electrical corporation subject to the commission's jurisdiction shall—

(4) In prescribing this system of accounts, the commission does not commit itself to the approval or acceptance of any item set out in any account for the purpose of fixing rates or in determining other matters before the commission. This rule shall not be construed as waiving any recordkeeping requirement in effect prior to *[1994]* **2026**.
