ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

Issue Date: September 1, 2026

Effective Date: September 1, 2026

On September 1, 2026, The Empire District Gas Company d/b/a Liberty (Empire) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet in Tracking No. JG-2027-0033. Empire projects that the changes to the WNAR tariff sheets will increase the average monthly bill of the typical residential customer in its North, Northwest, and South systems by \$1.13 for each system. The tariff sheet bears an October 1, 2026, effective date.

The Staff of the Commission (Staff) will be directed to file a recommendation. The Commission will establish a deadline for any other entity to file a response to the proposed tariff changes or to the Staff recommendation.

THE COMMISSION ORDERS THAT:

1. No later than September 14, 2026, Staff shall file a recommendation regarding Tracking No. JG-2027-0033.

2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so no later than September 16, 2026.

3. This order is effective when issued.
