On August 31, 2026, Evergy Metro, Inc. d/b/a/ Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West (collectively, Evergy) filed the above-referenced application. Evergy wishes to construct a 710 MW combined-cycle gas turbine electric generating plant, known as the Buchanan Bluffs Energy Center Unit 2, in Buchanan County, Missouri. Evergy also wishes to construct a 109 MW battery energy storage system, known as the Foxtrot BESS Project, in Jasper County, Missouri.

The Commission will give notice of the application, and it will further allow an opportunity for interested parties to apply for intervention.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order to the county commissions for Buchanan and Jasper Counties, Missouri.

2. The Commission's Public Policy and Outreach Department shall provide notice of this application through any appropriate social media and news media outlets serving residents in Buchanan and Jasper Counties, Missouri.

3. Applications to intervene shall be filed no later than September 17, 2026.

4. This order shall be effective when issued.
