STAFF’S TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Tariff Recommendation* states as follows:

1. On September 1, 2026, Liberty Utilities (Midstates Natural Gas) Corp., d/b/a Liberty (“Liberty Midstates”) filed proposed revisions to its Weather Normalization Adjustment Rider (“WNAR”) tariff sheet assigned Tracking Number JG-2027-0032.

2. Also on September 1, 2026, the Commission issued an order directing Staff to file a recommendation regarding Tracking Number JG-2027-0032 no later than September 14, 2025.

3. Accompanying this pleading, and incorporated herein by reference, is Staff’s Memorandum recommending Commission approval of the WNAR rates Liberty Midstates filed in its September 1, 2026, substitute tariff sheet.

4. The effect of Liberty Midstates’ WNAR tariff sheet filing means that residential customers of Liberty Midstates’ Northeast District who used 100 Ccf¹ of natural gas in a given billing month would see an approximate \$2.76 bill increase from current effective rates, and small general service class customers using 100 Ccf of gas will see an approximately \$1.11 bill increase in their bill from current effective rates. The effect on

¹ Ccf stands for one hundred cubic feet of gas.

Liberty Midstates' residential customers of its West District who used 100 Ccf of natural gas would see an approximate \$3.94 bill increase from current effective rates, and small general service class customers using 100 Ccf of gas will see an approximate \$1.50 increase in their bill from current effective rates. The effect on Liberty Midstates' residential customers of its Southeast District who used 100 Ccf of natural gas would see an approximate \$0.84 bill increase from current effective rates, and small general service class customers using 100 Ccf of gas will see an approximate \$0.30 increase in their bill from current effective rates.

5. Staff has verified that Liberty Midstates has filed its Annual Report. Staff is not aware of any other matter pending before the Commission that affects or is affected by this filing. Due to the expedited nature of the review, Staff's recommendation is based on a limited review of the application and supporting materials.

6. Staff recommends approval of the filed substitute tariff sheet in Tracking No. JG-2027-0032, as follows:

WHEREFORE, as set forth in Staff's Memorandum, Staff recommends the Commission issue an order approving Liberty Midstates' WNAR substitute tariff sheet to go into effect on October 1, 2026.

SUBJECT: Staff Recommendation for the **Approval** of the Revised Tariff Sheet Filed by Liberty Utilities to reflect its Weather Normalization Adjustment Rider (WNAR) to go into effect on October 1, 2026.

DATE: September 11, 2026

On September 1, 2026, Liberty Utilities (Midstates Natural Gas) Corp., d/b/a Liberty (“Liberty MNG”) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet pursuant to Liberty MNG’s annual adjustment with a requested effective date of October 1, 2026. On September 1, 2026, the Commission directed Staff to file a recommendation regarding the WNAR Tariff Sheets in Tariff Tracking No. JG-2027-0032 no later than September 14, 2026. After its review, Staff recommends approval of the tariff sheet in Tracking No. JG-2027-0032.

Liberty MNG’s WNAR became effective July 1, 2018, and was modified in rate case GR-2024-0106 to be filed annually rather than semi-annually, effective January 8, 2025. The purpose of the tariff is to reflect the annual adjustment made pursuant to Liberty MNG’s WNAR for the twelve-month period ending September 30, 2027. Liberty MNG calculated the rates annually to account for variations in temperature within its service areas based on the difference between the actual heating degree days and the normalized heating degree days. Liberty MNG’s current and proposed rates are included in Table 1 below.

Based on weather variations in Liberty MNG's service districts, proposed residential rates and the small general service class rates for Liberty MNG's district service areas will increase customer bills that will be applied as a separate line item on a customer's bill. A residential customer using 100 Ccf of natural gas in a given billing month in Liberty MNG's Northeast district will see an approximate \$2.76 increase in their bill from the currently effective WNAR rate, and a small general service class customer using 100 Ccf of gas in Liberty MNG's Northeast district will see an approximate \$1.11 increase in their bill from the currently effective WNAR rate. A residential customer using 100 Ccf of natural gas in a given billing month in Liberty MNG's West district will see an approximate \$3.94 increase in their bill from the currently effective WNAR rate, and a similar small general service class customer will see an approximate \$1.50 increase in their bill from the currently effective WNAR rate. Likewise, a residential customer using 100 Ccf of natural gas in a given billing month in Liberty MNG's Southeast district will see an approximate \$0.84 increase in their bill from the currently effective WNAR rate, and a similar small general service class customer will see an approximate \$0.30 increase in their bill from the currently effective WNAR rate.

Staff Recommendation

Staff has reviewed and recommends approval of the following tariff sheet, filed on September 1, 2026, to go into effect for service on and after October 1, 2026, the requested effective date:

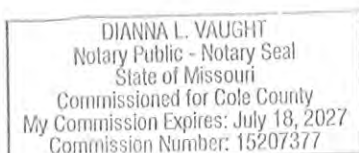

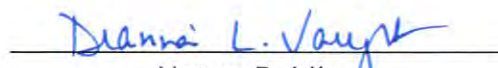
