ORDER GRANTING SUSPENSION OF STAFF RECOMMENDATION

On July 27, 2026,¹ the Commission ordered the Staff of the Commission (Staff) to submit a Recommendation on the above captioned application by September 14.²

On August 20, a procedural conference was held in the above-captioned case. The parties were directed to submit a proposed procedural schedule by August 28, later extended to September 18.

On September 11, Staff filed *Staff's Motion to Vacate or Suspend September 14 Filing Requirement* (Motion). The Motion states that the the September 14 Staff filing requirement has effectively been superseded by the subsequent procedural orders and no longer fits the present procedural posture of the case. The Motion requests the Commission vacate or suspend the filing requirement until the Commission establishes a procedural schedule.

The Commission finds the requested suspension to be reasonable and will grant it.
