Therefore, the Commission will direct the parties to file proposed dates and locations for Local Public Hearings.

The Commission will also direct the parties to propose language to be included in the notice sent to customers about the local public hearings. Staff shall consult with the parties and file the proposed language to be included in the notice. Parties may also file their own proposed language for public hearing notices.

THE COMMISSION ORDERS THAT:

1. The parties shall file proposed locations for Local Public Hearings no later than September 30, 2026.
2. Any proposed language to be included in the notice sent to customers about the local public hearings shall be filed no later than September 30, 2026.

3. This order shall be effective when issued.
