On August 26, 2026, the Commission issued its *Order Directing Notice, Establishing Intervention Deadline, and Setting Procedural Schedule*. On September 8, 2026, the Staff of the Commission and the Office of the Public Counsel filed their *Joint Motion for Reconsideration and Waiver of 20 CSR 4240-20.094(4)(H)* (Joint Motion).

To expedite consideration of the Joint Motion, the Commission will shorten the time allowed to respond to the motion.¹

THE COMMISSION ORDERS THAT:

1. Any responses to the Joint Motion shall be filed no later than September 16, 2026.
2. This order shall be effective when issued.
