ORDER APPROVING TARIFF

On September 2, 2026, the Commission granted Spire Missouri Inc. (Spire) a certificate of convenience and necessity. On September 3, 2026, Spire filed tariff sheets assigned Tracking No. JG-2027-0035 to comply with the Commission's September 2, 2026 order granting the certificate. The tariff sheets bear an effective date of October 3, 2026.

The Commission's Staff filed a Recommendation on September 9, 2026. The Recommendation stated that the Commission should approve the tariff sheets. No other responses were received.

The Commission finds that the tariff complies with the Commission's September 2, 2026 order. The Commission will approve the tariff.

THE COMMISSION ORDERS THAT:

1. The tariff filed by Spire on September 3, 2026, and assigned Tracking No. JG-2027-0035 is approved to become effective on October 3, 2026.
2. This order shall be effective October 3, 2026.
