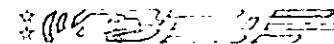

ORDER DIRECTING FILING

On February 1, 2006, Kansas City Power & Light Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for electrical service provided in its Missouri service area. KCPL's tariffs are due to go into effect on January 1, 2007.

On December 4 and 5, Staff filed non-unanimous stipulations. Commission Rule 4 CSR 240-2.115(2)(B) allows parties seven days to respond to non-unanimous stipulations. However, due to the quickly approaching operation of law date, the Commission will shorten the time for parties to respond. Failure to timely respond shall be a waiver of objections to those stipulations.

IT IS ORDERED THAT:

1. Any party who wishes to respond to the Nonunanimous Stipulations and Agreements filed by the Staff of the Commission on December 4 and 5, 2006 shall respond no later than December 11, 2006.

2. This order shall become effective on December 7, 2006.
