**ORDER GRANTING MOTIONS FOR RECONSIDERATION**

Issue Date: April 9, 2015

Effective Date: April 9, 2015

The Commission established a procedural schedule for this case on December 12, 2014, which was amended on January 14, 2015 to include a deadline for requests for additional amendments. On March 11, 2015, the Commission again amended the procedural schedule by changing the deadlines for position statements and surrebuttal testimony, as well as establishing a cut-off date for discovery.

On March 17, 2015, Staff filed a Request for Clarification and Reconsideration of Parts of Order Amending Procedural Schedule, requesting that the Commission take the following actions:

1. Move the deadline for filing surrebuttal testimony to June 5, 2015.
2. Move the due date for filing the list of issues from June 9, 2015 to June 8, 2015, so that the list of issues will be filed at the same time as the position statements.
3. Move the discovery cut-off date from June 5, 2015 to June 9, 2015, to allow a few days for discovery after the filing of surrebuttal testimony, and clarify that the discovery cut-off deadline does not apply to true-up issues.

Similar motions for reconsideration filed by Midwest Energy Consumers Group, Missouri Industrial Energy Consumers, Sierra Club, and the Office of the Public Counsel

also request that the date for filing surrebuttal testimony be changed to June 5, 2015. Ten days have elapsed, and no parties have objected or responded to the motions for reconsideration.<sup>1</sup>

After considering the unopposed arguments of the moving parties, the Commission concludes that the requests to amend the procedural schedule are reasonable. The Commission will grant the motions for reconsideration.

**THE COMMISSION ORDERS THAT:**

1. The motions for reconsideration filed by Staff, Midwest Energy Consumers Group, Missouri Industrial Energy Consumers, Sierra Club, and the Office of the Public Counsel are granted.

2. The deadline for the filing of surrebuttal testimony is changed from May 29, 2015 to June 5, 2015.

3. The deadline for filing the list of issues is changed from June 9, 2015 to June 8, 2015.

4. The last day that parties may issue any discovery requests or conduct a deposition shall be June 9, 2015. This discovery deadline does not apply to true-up issues.

5. All other provisions of the existing procedural schedule, as amended, shall remain in effect.
