**STAFF'S SECOND MOTION FOR EXTENSION OF TIME  
TO FILE PROCEDURAL PLEADING**

Comes now the Staff of the Missouri Public Service Commission (Staff), through the Office of Staff Counsel, in response to the Missouri Public Service Commission's (Commission) October 21, 2010 Order Extending Time To File Procedural Schedule, the October 12, 2010 early prehearing conference, and the Commission's September 7, 2010 Order Directing Notice, Suspending Tariff, Setting Hearings, And Directing Filings, and requests an additional extension of time until Monday, November 1, 2010 for the filing of a procedural pleading proposing a procedural schedule, recommendations for local public hearings, and for filings respecting the test year and true-up, among other things. In support thereof, the Staff states as follows:

1. As the Staff indicated on October 26, 2010, when it requested a three (3) day extension of time to October 29, 2010 to file a procedural pleading, the Parties to this proceeding are presently attempting to address various items which cover a range of matters including the routine, the infrequent, and the unique.

2. The Staff believes that resolution was reached in principle on Friday, October 29, 2010, but the demands of other Commission cases prevented undersigned Staff counsel from circulating to the other Parties final proposed language, which it is believed will attain resolution of the remaining outstanding matters. Other Staff counsel addressing other Commission matters did not, and in other situations may not, permit a simple resolution of just assigning or delegating certain tasks to other Staff counsel.

3. The Staff does not ask the Commission for an additional extension of time to unduly delay these proceedings, nor does the Staff ask the Commission for an additional extension of time to vex the Commission or Ameren Missouri.

4. The Staff has advised counsel for Ameren Missouri that it would be filing Staff's Second Motion For Extension Of Time To File Procedural Pleading.

Wherefore the Staff requests a extension of time until Monday, November 1, 2010 for the filing of a procedural pleading proposing a procedural schedule, recommendations for local public hearings, and filings respecting the test year and true-up, among other things.
