## CORRECTION OF STAFF RECOMMENDATION TO APPROVE TARIFF SHEET AND MOTION TO CORRECT COMMISSION ORDER

**COMES NOW** the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), by and through counsel, and for its *Correction of Staff Recommendation to Approve Tariff Sheet* states as follows:

1. On October 28, 2010, Union Electric Company d/b/a Ameren Missouri ("Company") filed proposed Net Metering tariff sheets with a request for a variance from a requirement in a Commission rule.

2. On November 18, 2010, Staff filed its *Recommendation to Grant Variance and Approve Tariff Sheets*.

3. On November 23, 2010, the Commission filed its Order Granting Request for Waiver of a Portion of Commission Regulations Governing Net Metering and Order Granting Motion to Accept Late Filing.

4. On November 24, 2010, Staff was alerted to the fact that its Memorandum, Appendix A of the November 18, 2010, filing, contained a typographical error, which was then inadvertently carried on to the *Recommendation*, and also on to the Commission's *Order*.

5. Staff hereby clarifies that the twelfth line under "P.S.C.MO. SCHEDULE No. 1," on page four of Appendix A, which reads, "2<sup>nd</sup> Revised Sheet No. 15 Cancelling 1<sup>st</sup> Revised Sheet No. 15," should read as follows:

3<sup>rd</sup> Revised Sheet No. 15 Cancelling 2<sup>nd</sup> Revised Sheet No. 15

6. As this was a typographical error regarding the number of tariff sheet revisions, there is no change to the substance of Appendix A, the *Recommendation*, or the Commission's *Order*, and no parties' rights will be affected by the correction.

**WHEREFORE,** the Staff submits its *Correction of Staff Recommendation to Approve Tariff Sheet*, and respectfully request that the Commission's *Order* be amended to reflect the correction.
