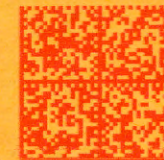

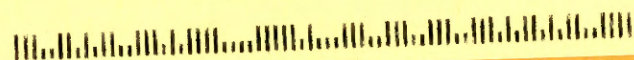

ORDER TO PROVIDE NOTICE TO CITIES AND COUNTIES OF ELECTRIC RATE INCREASE AS REQUIRED BY SECTION 393.275.1, RSMO

Issue Date: January 3, 2013

Effective Date: January 3, 2013

Section 393.275.1 RSMo (2000) requires the Commission to notify the governing body of each city or county imposing a business license tax on gross receipts of any electric corporation of any approved rate increase for that electric corporation that exceeds seven percent. Further, the statute requires the Commission to:

include with such notice to any city or county the percentage increase approved for the utility, together with an estimate of the annual increase in gross receipts resulting from the tariff increase on customers residing in that city or county.

Section 393.275.2 then requires the taxing authority to reduce its tax rate to reduce the amount of revenue collected under the tax.

On December 12, 2012, the Commission issued a report and order that allowed Ameren Missouri increase the company's annual revenues from its provision of electric service by 10.05%. On December 27, 2012, the Commission approved Ameren Missouri's tariff to implement the allowed rate increase. On January 3, 2013, the Commission denied rehearing requests.

As required by the statute and a Commission Regulation, Ameren Missouri has submitted a list of the cities and counties within its service territory that impose a business license tax on its gross receipts, along with an estimate of the annual increase in gross receipts resulting from the rate increase on customers residing in that city or county. That list and revenue increase estimate is attached to this Notice.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall mail a copy of this order to each city or county identified by Union Electric Company, d/b/a Ameren Missouri.
2. This order shall become effective immediately upon issuance.

BY REPORT AND ORDER**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or the "Company"), by and through counsel and, in compliance with Ordering Paragraph 3 on page 119 of the Commission's *Report and Order* issued in this case hereby files the information required by Section 393.275.1, RSMo. and Commission Rule 4 CSR 240-10.060. Ameren Missouri states as follows respecting this compliance filing:

1. Section 393.275.1, RSMo. requires the Commission to provide notice and certain information to municipalities whenever the Commission approves a rate increase of more than 7%. Commission rule 4 CSR 240-10.060 requires the utility to provide certain information to the Commission so that the Commission can discharge its statutory obligations.

2. On December 12, 2012, the Commission issued the *Report and Order*, which authorized an increase of approximately 10.05%, thus triggering application of the above-referenced statute and rule.

3. The *Report and Order* directed the Company to file the information required by the above-referenced statute and rule no later than January 14, 2013.

4. Attached hereto is the information required by the statute and the rule.

WHEREFORE, Ameren Missouri requests that the Commission accept this information in compliance with the directive contained in the *Report and Order*.
