**MOTION FOR ADDITIONAL TIME TO FILE LIST OF ISSUES,
ORDER OF CROSS-EXAMINATION, ORDER OF OPENINGS,
LIST OF WITNESSES AND RECONCILIATION**

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and states:

1. On April 26, 2012, the Commission consolidated these cases for hearing and ordered a procedural schedule that included, as Staff and some parties requested, the filing in Case No. ER-2012-0174 of a list of issues, order of cross, order of openings, list of witnesses and reconciliation today, October 9, 2012, and in Case No. ER-2012-0175 a similar filing on Thursday, October 11, 2012.

2. Starting even before the filing of surrebuttal testimony in Case No. ER-2012-0174 Staff has circulated to and solicited from Kansas City Power & Light Company suggested statements of the issues in both cases. Drafts have circulated to all the parties today, but it is apparent there will be no joint list of issues vetted among the parties that can be filed today.

3. Staff has inquired of the parties in both cases if they are amenable to making one filing on Thursday for both cases, although Staff did not reference the reconciliation in that request.

Those who responded agreed, or voiced no opposition.

4. Many parties are also pressed with preparing testimony for the surrebuttal filing in Case No. ER-2012-0175 due tomorrow and participating in the ongoing Ameren Missouri rate case, Case No. ER-2012-0166.

5. Inasmuch as there are issues common between the cases and scheduling based on witness availabilities will be coordinated for both, it is logical that there be only one filing that lists the issues in both cases and the hearing schedule.

WHEREFORE, Staff respectfully requests until Thursday, October 11, 2012, to file the list of issues, order of cross, order of openings, list of witnesses and reconciliation for Case NO. ER-2012-0174 jointly with the list of issues, order of cross, order of openings, list of witnesses and reconciliation due in Case No. ER-2012-0175 that is already due that day.
