## **ORDER DIRECTING NOTICE, SETTING INTERVENTION DATE, AND DIRECTING DATA CENTER TO ADD PARTIES TO THE SERVICE LIST**

On June 30, 2010, KCP&L Greater Missouri Operations Company (KCP&L-GMO) filed a tariff to adjust the rate the company recovers under the fuel adjustment clause initially approved by the Commission in the company's rate case, ER-2007-0004, and modified in a subsequent rate case, ER-2009-0090. For the accumulation period December 2009 through May 2010, KCPL-GMO reports that its actual FAC includable costs exceeded the base costs included in base rates by approximately \$19 million. As allowed by the Commission's rule and the company's approved FAC, KCPL-GMO's tariff filing would increase rates to recover 95 percent of those cost increases. The revised rates would result in a decrease to a typical customer's bill of approximately \$0.55 per month for customers in the company's MPS rate area, and an increase of approximately \$0.90 per month for customers in the company's L&P rate area.

The Commission will give notice of the filing of this tariff to the public and will set a date for the filing of intervention requests.

Commission Rule 4 CSR 240-3.161(10) provides that parties to the rate case in which the Commission established KCP&L-GMO's fuel adjustment clause are automatically parties to this tariff case, without the necessity of having to apply for

intervention. The Commission therefore acknowledges that the parties to ER-2007-0004 and ER-2009-0090 are parties to this case, and will direct its Data Center to add those parties to the service list.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall mail a copy of this order to the County Commission for each of the counties in KCP&L Greater Missouri Operations Company's service area.

2. The Commission's Information Officer shall make notice of this order available to the media serving KCP&L Greater Missouri Operations Company's service area.

3. The Commission's Data Center shall add all parties to Case Nos. ER-2007-0004 and ER-2009-0090 to the service list for this case.

4. Any person wishing to intervene in this matter shall file an application to do so no later than July 21, 2010. Such application shall be filed with:
