Staff doesn't perform a CCOS study that produces a revenue neutral percent or dollar amount. However, Staff's CCOS study does produce a total percent change, Staff subtracts the system average percent increase from the total percent change to calculate the revenue neutral percent change. Staff then calculates the revenue neutral amounts by multiplying rate revenue by revenue neutral percent.
