**ORDER SCHEDULING ON-THE-RECORD PRESENTATION  
REGARDING STIPULATIONS AND AGREEMENTS**

On May 3, 2011, Staff, Ameren Missouri, Public Counsel, the Missouri Industrial Energy Consumers (MIEC), Missouri Energy Group (MEG) and the Missouri Retailers Association filed a First Non-Unanimous Stipulation and Agreement – Miscellaneous Revenue Requirement Issues. On May 5, Ameren Missouri and MIEC filed a Non-Unanimous Stipulation and Agreement Regarding Tax Issues. On May 6, Staff, Ameren Missouri, and MIEC filed a Third Non-Unanimous Stipulation and Agreement. On May 12, Public Counsel, MIEC, AARP, the Consumers Council of Missouri, the Missouri Retailers Association, the Midwest Energy Users' Association, and MEG filed a Non-Unanimous Stipulation and Agreement regarding class cost of service allocation issues. Before deciding whether to approve any or all of those stipulations and agreements, the Commission would like to question the parties about the terms of those stipulations and agreements. The Commission will schedule an on-the-record presentation for that purpose.

The Commission has previously scheduled an evidentiary hearing regarding the class cost of service issues for May 20, beginning at 8:30 a.m. That hearing will only be necessary if one or more parties object to the non-unanimous stipulation and agreement

regarding the class cost of service issues. The Commission will schedule the on-the-record presentation regarding all the stipulations and agreements to begin at 10:00 a.m. on May 20. If the evidentiary hearing on the class cost of service issues proceeds, it will be recessed while the on-the-record presentation is conducted.

**THE COMMISSION ORDERS THAT:**

1. An on-the-record presentation regarding the First Non-Unanimous Stipulation and Agreement – Miscellaneous Revenue Requirement Issues, the Non-Unanimous Stipulation and Agreement Regarding Tax Issues, the Third Non-Unanimous Stipulation and Agreement, and the Non-Unanimous Stipulation and Agreement regarding class cost of service allocation issues, is scheduled for May 20, 2011, at 10:00 a.m., at the Commission’s office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310. This building meets accessibility standards required by the Americans with Disabilities Act.
