NOTICE OF COMPLIANCE AND REQUEST FOR CANCELLATIONS

COMES NOW Qwest Communications Corporation ("QCC"), Joint Applicant herein, by its undersigned counsel and in compliance with the *Order Approving Joint Application* issued in this matter on July 10, 2007 (effective July 20, 2007), and hereby notifies the Commission of the following:

1. The merger of OnFiber Carrier Services, Inc. into OnFiber Communications, Inc., and the merger of OnFiber Communications Inc. into Qwest Communications Corporation, have been completed.
2. Timely notice to customers has been sent to all customers affected by the merger, as required by Commission rule and directed by the Commission in the *Order*.
3. In its *Order Approving Joint Application* issued in this matter on July 10, 2007, in ORDERED: 2, the Commission directed:

Qwest Communications Corporation shall file a pleading in this case informing the Commission of when the merger is completed, so the Commission can cancel the certificate of service authority and tariff of OnFiber Carrier Services, Inc.

4. Joint Applicant hereby reiterates the request made in the Joint Application in this case, filed on May 15, 2007, for the Commission to cancel OnFiber Carrier Services, Inc.'s certificate of service authority (interexchange and non-switched local exchange).¹

5. In addition, Joint Applicant reiterates its request that the Commission cancel the OnFiber Carrier Services, Inc. tariff that is no longer required, which is PSC Mo. No. 1.

WHEREFORE, Qwest Communications Corporation ("QCC") respectfully submits its *Notice of Compliance and Request for Cancellations* in this case.
