**FIRST AMENDED APPLICATION BY INTERLINEATION**

COMES NOW Applicant Aquila, Inc., (hereinafter "Aquila" or "Company"), and for its First Amended Application by Interlineation states as follows:

1. On December 28, 2006, Aquila filed an Application for a certificate of public convenience and necessity authorizing it to construct a new electrical transmission substation in Benton County, Missouri, near the City of Cole Camp. The Application contains several incorrect references to the substation as a "distribution" substation. The Application is hereby amended in the following particulars.

2. The caption of the case should be amended to substitute the word "transmission" for the word "distribution" and should read, in its entirety, as follows:

In The Matter of the Application of Aquila, Inc. for Permission and Approval and a Certificate of Public Convenience and Necessity Authorizing it to Acquire, Construct, Install, Own, Operate, Maintain, and otherwise Control and Manage Electrical *Transmission* Substation and Related Facilities in Benton County, Missouri (Near the City of Cole Camp).

3. In the first clause in paragraph (A) of the prayer of the Application, the word "transmission" should be substituted for the word "distribution" in two locations such that the first clause reads as follows:

- (A) Granting Aquila permission and approval and a certificate of public convenience and necessity, to construct, install, own, operate, maintain, and otherwise control and manage

an electrical *transmission* substation together with any and all other facilities, structures, fixtures, equipment and installations related thereto, to be constructed for the *transmission* of electrical power and energy at the following described location in Benton County, Missouri:

4. The corrections in each case above are shown in italics for purposes of illustration only.

5. The amendments hereinabove are ministerial and do not represent a material change in the nature of the relief requested.

6. In all other respects, the Application, its allegations and appendices are hereby restated, ratified and confirmed.

WHEREFORE, having amended its Application as aforesaid, Aquila again requests that the Commission grant relief requested therein.


