Mike -

We would like to support the comments made by Renew MO and also add a comment about timely payment of the rebates. I remember this being discussed at the workshop, but just wanted to be sure it was stated again...

- The PSC needs to ensure that payment of the \$2/watt solar rebates are made in a timely manner, preferably within 30-45 days.
- The PSC needs to ensure that the \$2/watt rebate program is up and running smoothly on January 1st, 2010.
- The PSC needs to ensure that the rebate program is available year-round without interruption.
- The rebate, which applied to new or expanded systems up to 25kW in size, should be claimable once per year per customer that's why the terms "or expanded" were used. A customer shouldn't be limited to one rebate per lifetime. Either one per customer per year or one per meter per year will be appropriate.
- The PSC needs to ensure that an appropriate REC valuation and tracking system is in place as soon as possible, ideally by January 1st 2010.
- To count for the RES, energy should be required to be delivered into the Missouri power grid, restricting development to as close to possible around the state of Missouri.
