Enclosed for filing with the Missouri Public Service Commission ("Commission") on behalf of The Empire District Electric Company ("Empire"), please find in electronic format certain revised tariff sheets. These tariff sheets are being filed to comply with the Commission's Report and Order issued in Case No. ER-2008-0093 on July 30, 2008, effective August 9, 2008. The revised tariff sheets are designed to produce an increase in Empire's gross annual electric revenues of \$22,040,395, excluding gross receipt taxes, fees or other similar fees or taxes.

The revised tariff sheets being filed herewith are listed below. Each bears an issue date of August 6, 2008, and a proposed effective date of September 5, 2008 (thirty days after issue). Empire, however, requests that the revised tariff sheets, excluding those sheets designed to implement the fuel adjustment clause ("FAC"), be permitted to take effect for service rendered on and after August 23, 2008. Empire requests that the tariff sheets designed to implement the FAC authorized and approved by the Report and Order (tariff section 4, sheet numbers 17, 17a, 17b, and 17c) be permitted to take effect for service rendered on and after September 1, 2008. Empire makes these requests for good cause shown, all as explained in greater detail in the Motion for Expedited Treatment which is being filed herein.
