We represent the City of Hazelwood, Missouri. We are in receipt of a copy of your letter of August 30, 2007 to Mayor Carr.


The City's records reflect that Charter holds one franchise that expires August 25, 2008 and another combined franchise originating from TCI agreements that expires January 23, 2011.

Pursuant to the 2007 Video Services Providers Act, and on behalf of our client, we hereby notify you of the following:

1. The gross revenue fee percentage is 5%
2. Charter is required to adopt and abide by the customer service requirements set forth in Section 67.2692 RSMo
3. Charter is required to continue to designate channels for PEG use as set forth in the franchise documents

Please make certain that Charter continues to pay fees as required by law. Also, please make certain that Charter complies with all notice and reporting requirements of the Act.
