#### ORDER SUSPENDING TARIFF

On October 15, 2021, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a revised sheet to amend its Keeping Current tariff. That tariff was assigned tracking number YE-2022-0076. The tariff was given a 30-day effective date of November 14, 2021, but the cover letter accompanying the tariff indicated it should be suspended to match the suspension date of the other tariff revisions now pending in this general rate case. Those tariff sheets have been suspended until February 28, 2022. This tariff sheet will also be suspended until that date.
