STAFF RECOMMENDATION TO APPROVE TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Tariff Sheets*, and states the following in support:

1. On February 14, 2022, Union Electric Company d/b/a/ Ameren Missouri (Ameren Missouri) filed tariffs in Tariff Tracking No. YE-2022-0222 that Ameren Missouri stated in its accompanying tariff filing letter were intended to reflect the Commission's February 2, 2022 *Report and Order* and the Commission's December 22, 2021 *Order Approving Stipulations and Agreements*.

2. Ameren Missouri filed substitute tariff sheets 61.2, 89, 89.2, 89.3, 93.4, and 158.3 on February 17, 2022, and further filed substitute tariff sheet 160 on February 18, 2022, both in Tariff Tracking No. YE-2022-0222.

3. Staff has reviewed the tariff sheets filed in Tariff Tracking No. YE-2022-0222 as substituted on February 17 and February 18, and recommends the Commission approve them with an expedited effective date of February 28, 2022.

4. This pleading is verified by the affidavit of J Luebbert, which is incorporated by reference herein.

WHEREFORE, for the reasons stated above, Staff recommends the Commission issue an order approving the following tariff sheets filed in this matter,

Tariff Tracking No. YE-2022-0222, as substituted on February 17, 2022 and February 18, 2022, with an expedited effective date of February 28, 2022:




