ORDER GRANTING REQUEST FOR EXTENSION

On July 29, 2022, the Commission issued an order directing the Staff of the Commission (Staff) to file recommendations reporting Staff's examination and analysis of Union Electric Company d/b/a Ameren Missouri (Ameren Missouri's) application and tariff sheet in these two cases no later than August 22. On August 22, Staff filed a motion for extension, requesting an additional four days to conduct an accurate analysis of one of Ameren Missouri's discovery responses.

The Commission finds Staff's request to be reasonable and will grant Staff's request. The Commission will also extend the time for filing of Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation no later than August 26, 2022.
2. This order shall be effective when issued.
