Re: Name Change Request of Alltel Holding Corporate Services, Inc. to Windstream Communications, Inc; and the resulting Adoption of Tariffs of Alltel Communications, Inc. by Windstream Communications, Inc.

Dear Ms. Dale:

Pursuant to Missouri Public Service Commission ("Commission") Rules 4 CSR 240-2.060(5) and 4 CSR 240-3.545(20), Alltel Holding Corporate Services, Inc. ("AHCSI") respectfully requests that the Commission approve its name change from Alltel Holding Corporate Services, Inc. to Windstream Communications, Inc.

In addition, and in accordance with the Commission's <u>Order Approving</u> <u>Interexchange and Nonswitched Local Exchange Certificate of Service Authority</u> issued February 24, 2006 in Case No. XA-2006-0271 and its <u>Order Approving Stipulation and</u> <u>Agreement</u> issued April 25, 2006 in Case No. TM-2006-0272, Windstream Communications, Inc. is filing the attached Revised Adoption Notice and Revised Title Page, with a forty-five (45) day effective date, to effectuate the adoption of the current tariff of Alltel Communications, Inc.

Case No. TM-2006-0272 included a request for authority to transfer the resale interexchange service customer base of Alltel Communications, Inc. to AHCSI, which is a component of the overall transaction whereby Alltel Corporation is separating its incumbent local exchange and interexchange services businesses from its wireless business. Contemporaneous with that proceeding, AHCSI filed a separate application with the Commission for a certificate of service authority to provide interexchange telecommunications services and that matter was assigned Case No. XA-2006-0271, as referenced above. No tariff or adoption filings have been made by AHCSI in Missouri to date. As contemplated, and as referenced in the Unanimous Stipulation and Agreement

James M. Fischer Larry W. Dority in Case No. TM-2006-0272, AHCSI would change its name and the new name of AHCSI is Windstream Communications, Inc. The Unanimous Stipulation and Agreement, approved by the Commission, further reflects that the underlying tariffs of the current interexchange carrier, Alltel Communications, Inc., would be adopted by the new entity.

As required by 4 CSR 240-2.060(5)(B), evidence of registration of the name change from Alltel Holding Corporate Services, Inc. to Windstream Communications, Inc. with the Missouri Secretary of State is attached. In addition, as discussed above, an adoption notice and revised tariff title sheet with an effective date of at least 30 days after the filing date are attached, as required by 4 CSR 240-2.060(5)(C). There are no changes to the rates, terms or conditions of the tariffs, but merely the required adoption notice language under 4 CSR 240-3.545(20). Also attached, in conformance with 4 CSR 240-3.545(20), is a copy of the customer notice contained in previous billings notifying customers of the name change to Windstream Communications, Inc.

Windstream Communications, Inc.'s Revised Adoption Notice and Revised Title Page to the underlying Alltel Communications, Inc. Tariff MO P.S.C. No. 1 reflect an issued date of June 2, 2006, and an effective date of July 17, 2006.


