SECOND SUSPENSION ORDER

On December 26, 1979, Union Electric Company of St. Louis, Missouri, submitted to this Commission revised tariffs limiting maintenance on private area and municipal incandescent lighting for electric service provided to customers in the Missouri service area of the Company. The proposed tariffs had a requested effective date of January 28, 1980.

By Order dated January 25, 1980, the Commission suspended said proposed tariffs for a period of 120 days, until May 27, 1980.

It is the opinion of the Commission that said tariffs should be further suspended for an additional period of six (6) months beyond May 27, 1980, until November 27, 1980, unless otherwise ordered by this Commission.

It is, therefore,

ORDERED: 1. That all tariff sheets submitted on December 26, 1979, by Union Electric Company of St. Louis, Missouri, for the purpose of revising rate sheets for incandescent lighting service provided to customers in the Missouri service area of the Company be, and are, hereby suspended for an additional period of six (6) months beyond May 27, 1980, until November 27, 1980, unless otherwise ordered by this Commission.

ORDERED: 2. That this Order shall become effective on the date hereof.
