ORDER APPROVING RATE SHEETS

By its Order approving Stipulation and Agreement in this case on  
November 17, 1980, this Commission authorized Union Electric Company to file  
tariffs to terminate maintenance on incandescent lighting.

On November 21, 1980, Union Electric submitted new tariff sheets for  
Commission review and approval, to comply with the Commission's Order.

The Commission is of the opinion the proposed rates submitted November  
21, 1980, comply with its Order issued November 17, 1980, and said tariff sheets  
should be allowed to become effective on and after December 23, 1980, which  
terminates maintenance on June 30, 1981.

It is, therefore,

ORDERED: 1. That the following sheets submitted November 21, 1980,  
by Union Electric Company for the purpose of terminating maintenance for incan-  
descent lighting service provided to customers in its Missouri service area be,  
and they are, hereby approved and made effective on and after December 23, 1980.

The revised tariffs reflect the termination of maintenance for incandescent lighting under schedules 6(M), 7(M), and 8(M) after June 30, 1981. The Commission Order requires further action by the Company and other parties in the case, relating to the type of standards offered by the Company and conversion to mercury vapor lights.

This tariff change provides official notice that maintenance will terminate June 30, 1981. The Company has also agreed to provide a separate mailing to notify the affected customers of this change when the tariff is made effective.

The Staff recommends approval of these tariffs so that all customers have official notice of the termination of maintenance of the incandescent lighting.
