## AMENDMENT TO ANSWER

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company) and states as follows:

- 1. On December 3, 2008, Summerfield Inn d/b/a America's Value Inn of 4224 S. Clark Street, in Mexico, Missouri (Complainant) initiated this proceeding by filing a *Complaint* against AmerenUE.
  - 2. On January 6, 2009, AmerenUE filed its *Answer*.
- 3. Since filing its *Answer*, AmerenUE has discovered that the rebill was figured incorrectly, using an incorrect constant. AmerenUE rebilled Complainant using a constant of 1.656, but when the Company checked the physical meter, it found that it should have been rebilled at 1.317. Correction of this error reduces the amount owed by Complainant.
- 4. A corrected bill has been sent to Complainant and a copy is attached to this pleading as Exhibit 3HC.
  - 5. AmerenUE regrets this error but believes this amount due is now correct.

WHEREFORE, AmerenUE respectfully requests that the Commission issue an order dismissing this Complaint or, in the alternative, set the matter for hearing.
