

AMENDMENT TO APPLICATION

COMES NOW Telecommunications Cooperative Network, Inc., d/b/a TCN, Inc., (TCN or Applicant), and in response to the Commission's Second Order Requiring Filing (Order) which was issued December 3, 1999 files this Amendment to Application.

1. The Commission's Order required TCN to file an amended pleading or submit a substitute tariff sheet to correct an inconsistency in references to TCN's request for competitive classification within its Application and with its proposed tariff on or before December 8, 1999, at 3:00 p.m. or face possible suspension of its tariff.

2. The press of other business prevented the undersigned from filing this pleading on or before 3:00 p.m. on December 8, 1999, but it is being filed as soon as possible thereafter.


3. TCN's Application inadvertently requested only classification of its services as competitive when it should have sought classification of TCN as a competitive telecommunications company pursuant to the terms of Section 392.361. Classification as a competitive telecommunications company requires that all services of the company be classified as competitive.

4. The correction of the references would be as follows: page 1, first paragraph, fifth line should read: "392.410 RSMo., TCN requests that it be classified as a competitive telecommunications

company. In support"; page 3, paragraph 12, lines 1-2 should read: "12. TCN also seeks classification of TCN as a competitive telecommunications company, with accompanying reduced regulation, pursuant to §§ 392.361 and 392.420 RSMo."; page 5 (unnumbered page), WHEREFORE paragraph, line 3, should read: "services in the State of Missouri, classify Applicant as a competitive telecommunications company, and grant a". With these corrections, the inconsistency between the Application and tariff cover sheet would also be resolved.

WHEREFORE, with the above referenced corrections to TCN's Application, TCN respectfully requests the Commission issue Certificate of Service Authority, classify TCN as a competitive telecommunications company, waive the rules and statutes as referenced in the Application and approve TCN's pending IXC tariff.


