On August 21, 2008, Charter Communications Entertainment I, LLC d/b/a Charter Communications ("Charter") filed a Notice of Change Application regarding In The Matter of the Application of Charter Communications Entertainment I, LLC d/b/a Charter Communications for Video Service Authorization. The Notice of Change Application, as filed by Charter, included the political subdivisions of Brentwood, Missouri; Kirkwood, Missouri; Richmond Heights, Missouri; University City, Missouri; Warson Woods, Missouri; and, Shrewsbury, Missouri.

By this letter, Charter wishes to amend its Notice of Change Application as mentioned above by amending within Paragraph 2 of its application the deletion of the video service provider fee of three percent (3%) with respect to the political subdivision of Kirkwood, Missouri, and inserting in lieu thereof the video service provider fee of four and one-half percent (4.5%). I have also provided a revised copy of the Notice of Change Application, which reflects the fee amount change for the political subdivision of Kirkwood.
