## **PR-11-138 -- PSC Staff Files Complaint Against Water & Sewer Provider**

**FOR IMMEDIATE RELEASE -- MARCH 1, 2011**

**JEFFERSON CITY**—The staff of the Missouri Public Service Commission has filed a complaint against two individuals, Bennington, Inc. and Bennington Water, Inc. alleging they are holding themselves out as non-profit water and sewer corporations but fail to meet the requirements to be non-profit. Thus, the PSC staff alleges, they should be under the jurisdiction of the Missouri Public Service Commission.

The PSC staff complaint was filed against Respondents, Dennis and Toni Kallash, Bennington, Inc. and Bennington Water, Inc. The Respondents have until March 17, 2011 to respond to the complaint.

As part of its complaint, the PSC staff alleges the Respondents impose monthly charges upon its customers for water and sewer usage in violation of state law. The complaint further alleges the Respondents charge for the water and sewer services provided and those rates have not been deemed just and reasonable and not more than allowed by law or by order or decision of the Missouri Public Service Commission. Staff alleges the Respondents are unlawfully operating water and sewer corporations for gain under state law.

The PSC staff is seeking an order from the Missouri Public Service Commission that would require the Respondents to file for a certificate of public convenience and necessity to provide water and sewer service under the jurisdiction of the Missouri Public Service Commission. The Respondents would then be required to provide water and sewer service under PSC rules and regulations and the rates that would be charged would be determined by the Missouri Public Service Commission.

The water and sewer systems which are the subject of this complaint are located in Lincoln County near Troy, Missouri.

On December 4, 2012, Lincoln County Sewer and Water LLC (Company) submitted a request for increases in its annual water and sewer operating revenues to the Missouri Public Service Commission (Commission). The reason for the increases is to cover increases in expenses and investments in the Company's facilities.

By its request, the Company is seeking changes to its customer rates intended to generate an increase in its annual sewer operating revenues of \$13,382 (approximately 39.3%) and generate an increase in its annual water operating revenues of \$7,569 (approximately 18.59%) At the end of this notice is a table that compares the Company's current residential customer rates and the proposed residential rates.
