WHEREFORE, the Staff respectfully recommends the Commission approve Empire's tariff filing of February 28, 2013, or allow it to become effective by operation of law.

On February 27, 2013, the Missouri Public Service Commission ("Commission") issued its Report and Order ("Order") in Case No. ER-2012-0345, The Empire District Electric Company ("Empire" or "Company") general rate case. This Order approved an increase in the Company's overall Missouri jurisdictional gross annual electric revenues of \$30.7 million.

The Company filed tariff sheets on February 28, 2013, to comply with the Order. In its letter of transmittal accompanying the February 28, 2013 compliance filing, Empire requested an effective date of April 1, 2013.
