Dear Mr. Woodruff:

On September 30, 2016, The Empire District Electric Company (“Empire” or “the Company”) filed proposed rate schedules to adjust charges related to the Company’s approved Fuel & Purchase Power Adjustment Clause (“FAC”). That filing included the following tariff sheet:

Subsequent to its filing, Empire discovered nominal errors in values shown on lines 1, 3, and 10 of that tariff sheet. In the original filing, Line 1 (Total Energy Cost) showed a value of \$60,294,292, Line 3 (TEC-B) showed a value of (\$11,425,194), and Line 10 (Interest) showed a value of (\$37,164). The correct values for those lines are \$60,294,281, (\$11,425,205), and (\$37,172) respectively. No further changes to the Company’s filing are required to account for the error.


Staff is aware of the error and of Empire’s intent to correct its September 30 filing in the manner described in this letter. A copy of this letter also will be served on the Office of the Public Counsel and on counsel for each party to the Company’s last general rate case. Empire regrets the error and any confusion or inconvenience it may have caused any of those parties.
