On April 1, 2011, The Empire District Electric Company ("Empire") submitted revised Fuel Adjustment Clause ("FAC") tariff sheets pursuant to the Commission's Report and Order issued in Case's ER-2008-0093 and ER-2010-0130, effective June 1, 2011.

Since the filing of the compliance FAC tariff sheets on April 1, 2011 and after discussions with Missouri Public Service Commission Staff ("Staff"), it was determined that rather than filing two (2) revised FAC tariff sheets Empire should have filed a single revised FAC tariff sheet.

Accordingly, Empire hereby withdraws the two FAC tariff sheets (PSC Mo. No. 5, Sec. 4, sheet numbers 17c and 17g) filed on April 1, 2011 and submits a new FAC tariff sheet bearing sheet number 17g. This FAC tariff sheet bears an issue date of April 1, 2011 and an effective date of June 1, 2011. In addition, the substitute tariff sheet 17g reflects the correction of a typographical error in the formula displayed on line 1 of the sheet. The correction of the typographical error in the formula has been discussed with Staff and Staff agrees with the change. The subject revised tariff sheet is as follows:


