The accompanying tariff sheets issued by Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or the Company), are being transmitted for filing as a revision of Schedule No. 2, Schedule of Rates for Gas Service:

These tariff sheets are being issued November 26, 2012 to become effective on and after January 1, 2013.

The Company's current natural gas energy efficiency program is set to expire on December 31, 2012. These proposed tariff changes were discussed with the Energy Efficiency Advisory Group (EEAG) prior to filing. The EEAG consists of the Missouri Public Service Commission Staff, the Office of the Public Counsel, and the Missouri Department of Natural Resources.

A small pilot program has been included in these proposed tariffs. The pilot program is designed to increase participation by landlords by providing a slightly higher rebate on high efficiency natural gas furnaces and boilers. The pilot, if successful, will benefit those customers who have no control over the type of heating equipment installed in their rental units. The landlord pilot has been analyzed with the other measures being offered under the proposed tariff and it is cost effective. The pilot will be evaluated by the Company after the program has ended.

By August 1, 2013, the Company will present a proposed natural gas energy efficiency tariff, measures and incentive levels, to the EEAG for the 2014 program year, with the changes from the 2013 tariff clearly indicated. The Company will schedule discussions between the Company and the EEAG and file the 2014 program year tariff by September 30, 2013, with an effective date of January 1, 2014.

The EEAG has reviewed and provided input on the proposed tariff sheets. The EEAG does not oppose our proposed natural gas energy efficiency tariff.
