In the Matter of the Application of Fidelity Communication Services II, Inc., for Review and Reversal of the North American Number Plan Thousands-Block Pooling Administrator's Decision to Withhold Numbering Resources for the Bourbon, Missouri, Exchange

FIDELITY COMMUNICATION SERVICES II, INC. APPLICATION AND MOTION FOR EXPEDITED TREATMENT

INTRODUCTION

Fidelity Communications Services II, Inc. OCN 3356 (hereinafter referred to as "FCS II") files this application pursuant to 20 CSR 4240-2.060, -2.080, -28.016, and 47 C.F.R. § 52.15(g)(3)(iv), and respectfully requests that the Missouri Public Service Commission ("Commission") issue an order, on an expedited basis, that reviews and reverses the recent decision of the North American Numbering Plan Thousands-Block Pooling Administrator ("PA") to withhold certain numbering resources from FCS II.

The requested numbering resources are necessary to eliminate the routing and rating issues associated with the Local Routing Number (LRN) not residing in FCS II'S inventory. Back in September of 2004, FCS II donated several blocks of numbers back to the PA. Three of the blocks containing LRNs were included in the donation. In July 2019, FCS II received notice from its CABs vendor, RVW, Inc. that the Embarq files were considerably smaller than normal. For example, the previous month's file was 261KB and now it is only 16KB. The smaller file relates to a lower volume of minutes

being received and billed. FCS II has tried to get its numbering resources back from the PA, but it does not meet the Months-to-Exhaust Worksheet requirements.

For its Application, FCS II states as follows:

- FCS II is a Missouri corporation with its principal office at 64 North Clark Street,
 Sullivan, MO 63080. FCS II is in good standing as evidenced by the Certificate of Good
 Standing issued by the Missouri Secretary of State and attached hereto as Exhibit E.
- 2. FCS II is a "local exchange telecommunications company," and "public utility" certificated by this Commission and duly authorized to provide "telecommunications service" within the state of Missouri¹, as each of these terms is defined in Section 386.020, RSMo.
- 3. In addition to the undersigned, all correspondence, pleadings, orders, decisions, and communications regarding this proceeding should be sent to:

4. As mentioned above, this Application is prompted by FCS II's plan and desire to capture all minutes of traffic traversing its switch, create accurate CABS billing and receive appropriate compensation for its switching function. Without the LRN's in the proper switch this hinders the routing of the call and thus the rating of the minutes. This request is for the return of the blocks of numbers to which the LRNs have been assigned back to FCS II's inventory with their respective "A" record codes responsible for default routing. The rate center and block involved in this Application is Bourbon, 573-679-0.

- 5. On August 22, 2019 a request to the PA for the blocks in Bourbon was submitted, along with the necessary Months to Exhaust (MTE) and Utilization Certification Work Sheet. A true and correct copy of FCS II's request, Part 1A and Part 3 is attached hereto as **Exhibit A.** The accompanying months-to-exhaust worksheet, which contains confidential market specific information relating to services offered in competition with others, is attached hereto as **Confidential Exhibit B.** As required by 4 CSR 240-28.016, FCS II's FCC Form UI of Form 502, which also contains confidential market specific information, is attached as **Confidential Exhibit C.**
- 6. On August 22, 2019, the PA denied the request for Bourbon on the grounds that FCS II had not met the utilization and/or months-to-exhaust criteria established by the Federal Communications Commission ("FCC"). A true and correct copy of the PA's decision for this exchange is attached hereto as **Confidential Exhibit D**, as it contains market specific information relating to services offered in competition with others.
- 7. FCS II seeks a Commission's Order overturning the PA's decision to withhold numbering resources, as FCS II has now exhausted all other available remedies designed to conserve numbering resources. The Commission has previously overturned decisions of the PA where the facts demonstrate good cause to do so.
- 8. A state commission may overturn the PA's decision based on the commission's determination that the carrier has demonstrated a verifiable need for the requested numbering resources and has exhausted all other available remedies.
- 9. In this case, FCS II requires the blocks and the associated Local Routing Numbers to be in their numbering inventory on their switch to prevent routing, rating, and billing issues.

10. FCS II respectfully requests that the Commission act upon this Application within twenty (20) business days so that it will be able to accurately record and bill for all traffic that it switches. FCS II has acted expeditiously to file for the requested relief, and the FCC has recognized the importance of timely state commission action:

[W]e recognize that in many instances, the failure to address a request for additional numbering resources can impair a carrier's ability to stay in or expand business. We therefore direct states to act on carrier requests for a safety valve as expeditiously as possible. Although we do not establish a specific time limit for states to act on these requests, we believe that, in most instances, 10 business days from receipt of a request that the state determines to be sufficiently detailed and complete will be sufficient time to review and act upon safety valve requests.²

- 11. This Application satisfies the requirements of 20 CSR 4240-28.016 by providing all required documentation outlined therein.
- 12. FCS II does not have any pending or final unsatisfied judgments or decisions against it from any state or federal agency, which involves customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Application.
- 13. FCS II does not have any annual report or assessment fees that are overdue in Missouri.
- 14. FCS II seeks expedited treatment and requests that the Commission act on this request within twenty (20) business days, so that and FCS II will have enough time to file a new request with the PA for the release of the numbering resources described herein, and upon release of those numbering resources, FCS II can accurately record and bill for all traffic it switches.

WHEREFORE, FCS II requests that the Commission overturn the PA's previous determination in this matter within twenty (20) business days and instruct the PA to release the numbering resources necessary to meet FCS II's routing and rating issues.
