**COMES NOW**, Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri or Company), and states as follows:

1. The Company filed its Integrated Resource Plan Annual Update Report on March 15, 2013.
2. Ameren Missouri is hosting its annual update workshop on April 5, 2013. Some of the information to be discussed is Highly Confidential.
3. The Missouri Public Service Commission (Commission) has not set an intervention deadline and no party has yet filed for intervention.
