Canton has a problem. I got a call just before lunch today from the design engineer who has the Canton OT and TT. It seems Century's route to Canton from Wentzville is exhausted. They can get the cards needed (TE port cards are on order for Socket). However, the route belongs to LightCore and they are not planning to expand that route in the near future.

The engineer, Daryl Burkemper (636-332-3389) promised to keep me updated on a possible due date. He had no information on it as of today, so the orders are in delayed status for now. I will check with him tomorrow before COB to see if he's made any headway. He has escalated the problem with his superiors.
