Dear Commission,

We are opposed to the attempt by Rolla Municipal Utilities to take over our electric service from Intercounty Electric Coop. for the following reasons:

1. When we made the decision to vote in favor of annexation of our neighborhood by the city of Rolla several years ago we were told, by a representative of the city, that we could choose whether to switch to RMU or to continue with Intercounty Electric. We chose to remain with Intercounty Electric, and we believed that the decision was ours to make.
2. The service provided to us by Intercounty Electric is more consistent than that provided to some of our neighbors by RMU. We have come to this conclusion by observing the frequency and length of power outages during the past several years.
3. We are completely satisfied with the fast and friendly service provided to us by Intercounty Electric. As an example of exceptionally friendly service, several years ago we had a lightning strike that destroyed the electric cable in our yard. Intercounty Electric fixed the problem at no charge on the day we called them, even though it apparently should have been our responsibility to arrange and pay for the repair. The representative of Intercounty Electric commented that their crews were not very busy that day, and that they would be happy to repair our cable.

In conclusion, we are completely satisfied with the electric service provided to us by Intercounty Electric, and we definitely do not want RMU to "take over" our service.
