Yes, Lauren. Sorry, this is the same company that Governor Kelly met with their CEO in early March. They are building a high-voltage electric transmission line that will begin in Spearville and bring Kansas wind to market in the east coast. The project’s total investment is \$8B with \$6B of direct investment from new wind generation and the line itself occurring in Kansas. The project is moving into its next phase and the company plans to announce this development.
