NOTIFICATION

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and, pursuant to the terms of its tariffs approved to implement the energy efficiency portfolio approved in this case, submits the following:

- 1. Ameren Missouri's Change Process tariff, found at Sheet No. 221.4 of its Energy Efficiency MEEIA 2019-21 tariffs, states that the Company will file a notice in this case prior to making a change in its measure and/or incentive amount offering.
- 2. Ameren Missouri is modifying the incentives offered for three of its business energy efficiency programs. Specifically, Ameren Missouri is making the following modifications, effective February 1, 2020:
 - **Standard:** Ameren Missouri is transferring three measures from its Custom business programs to its Standard business programs, where we expect to see participation increase. ¹ All of these programs are already included in Ameren Missouri's Technical Resource Manual ("TRM") and Deemed Savings Table:
 - o HVAC measures moving from Custom to Standard:
 - Roof Top Unit Controls
 - Demand Control Ventilation measure.
 - o Refrigeration measure moving from Custom to Standard:

¹ To date, the inclusion of these measures in the Custom program has meant the complexity of the calculations to qualify has been prohibitive as compared to the measures' potentials.

- Electronically Communicated Motor measure
- o Compressed Air measures moving from Custom to Standard:
 - No Loss Condensate Drain
 - High-Efficiency Air Nozzle
- Small Business Direct Install ("SBDI"): Ameren Missouri is adding new
 measure in HVAC, comparing the current business measures to residential
 program measures. This will impact the incentive ranges, as reflected in the
 attachment to this Notice.
- **Business Social Services ("BSS").** Ameren Missouri is making two overall revisions to its BSS program:
 - The Company will offer as part of its BSS program the three measures cited above that are moving from Customer to Standard;² and
 - The Company will also reduce the lighting measures, limiting to LED Types B and C, to better align with the budget and to serve more customers.
- HVAC Incentive Ranges. Finally, the Company is modifying the incentive ranges for its business HVAC programs to cover current and future incentive adjustments to match residential HVAC programs.
- 3. In accordance with the Change Process tariff, Ameren Missouri is providing notice of these changes, so that the 11-Step Change Process may be considered officially

² In other words, the Company will offer as part of its BSS program the two referenced HVAC measures (Roof Top Unit Controls and Demand Control Ventilation measures), the one referenced Refrigeration measure (Electronically Communicated Motor measure), and the two referenced Compressed Air measures (No Loss Condensate Drain and High-Efficiency Air Nozzle).

complete. Ameren Missouri will implement the changes for the residential programs only if the caps are met. Please see attachment A, which represents a redline of the revisions.

WHEREFORE, Ameren Missouri respectfully files this *Notification* in compliance with the terms of its tariff.
