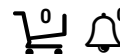

Introduction

American Water Resources, LLC, American Water Resources of Florida, LLC, American Water Resources of Texas, LLC, and Pivotal Home Solutions, LLC (collectively, "AWR/PHS," "we" or "us") are serious about protecting your privacy. We understand your concerns with regard to how information about you is used and we appreciate your trust that we will treat your information responsibly. This privacy policy ("Privacy Policy") describes what information we collect about you, how we collect it, how we use it, with whom we may share it, and what choices you have regarding our use of your information.

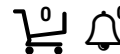
background, employment history or current or previous compensation.

Information We Automatically Collect

In addition to the types of information we may collect, AWR/PHS may retain the content of and metadata regarding any correspondence between you and AWR/PHS or our representatives, regardless of the mode of communication by which such correspondence was made. This information helps us improve the Site and the online media, content, materials, opportunities and services that we feature or describe on the Site and to more effectively and efficiently respond to both current and future inquiries.

With Whom Do We Share Information That We Collect?

AWR/PHS may, as appropriate, transfer Collected Information, whether solicited or unsolicited, to our offices throughout the country, catalog and add such Collected Information to our databases, transmit such Collected Information to our affiliates and contractors and, to the extent necessary to accomplish the purpose for which information was submitted, to other third parties (e.g., to the relevant financial institutions in making payments).

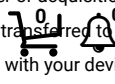

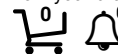

California and Virginia Privacy Rights

The following provisions apply to California and Virginia Consumers, who are granted certain rights over their personal data under their respective state's applicable laws. You have the right to exercise these rights detailed below via an authorized agent who meets the agency requirements of applicable state laws.

To access or delete specific pieces of personal information we will need to verify your identity to the degree of certainty required by law. A third party authorization form will be required to authorize third parties to make an access or deletion request on your behalf. As permitted by applicable law, any request you submit to us is subject to an identification and residency verification process ("Verifiable Consumer Request"). We will not fulfill your request unless you have provided sufficient information for us to reasonably verify you are the consumer about whom we collected personal information.

Sale of Personal Information

We do not "sell" personal information, as the term is defined in the California Consumer Privacy Rights Act, as amended by the California Privacy Rights Act.

Your Right to Know, Delete, and Correct

You have the right to request that we disclose certain information to you about our collection and use of your personal data over the past 12 months. Once we receive and validate your request, we will include a list of your personal data that may have been disclosed and the categories of third parties the information may have been disclosed to.

You may request that we delete any of your personal data that we collected from you and retained, subject to certain exceptions. Once we receive your request and confirm your identity, we will review your request. We may deny your deletion request if retaining the information is proper and necessary or if an exception allowing us to retain the information applies.

You may also request that we correct any of your personal data that has become outdated or needs correction for any reason.

If your request is approved, we will delete, correct, or deidentify the relevant information and will direct our service providers to take similar action.

Only you, or someone legally authorized to act on your behalf

You may only submit a request to know twice within a 12-month period. We endeavor to substantively respond to a Verifiable Consumer Request within forty-five (45) days of its receipt, unless we require an extension. If we reasonably require an extension we will inform you of the reason and extension period.

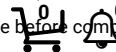
Non-Discrimination

California's Shine the Light Law
