On April 15, 2016, KCP&L Greater Missouri Operations Company (GMO) filed its 2016 Renewable Energy Standard Compliance Plan, as required by Commission Rule 4 CSR 240-20.100(8). That regulation requires Staff to file a report about the plan, and offers other interested persons or entities an opportunity to file comments. Staff filed its report on May 27, finding no deficiencies in GMO's plan. United For Missouri filed comments on May 28. In its comments, United of Missouri asks the Commission to direct GMO to "provide a reasoned analysis why the compliance plan is the least cost, prudent methodology to achieve compliance with the RES as required in its rule".

Commission Rule 4 CSR 240-20.100(8)(F) allows the Commission to direct GMO to provide additional information or to address any concerns or deficiencies identified by Staff or any other commenter. Before deciding whether any additional information is required or whether any concerns or deficiencies need to be addressed, the Commission will establish a time for the filing of responses to Staff's report and United for Missouri's comments.

THE COMMISSION ORDERS THAT:

1. Any person or entity wishing to respond to Staff's Report on KCP&L Greater Missouri Operations Company's 2016-2018 Renewable Energy Standard Compliance Plan, or to the Comments of United for Missouri, Inc., shall do so no later than June 13, 2016.

2. This order shall be effective when issued.
