**ORDER ESTABLISHING TIME TO RESPOND TO STAFF'S REPORTS  
AND STAKEHOLDER COMMENTS**

On April 15, 2016, Union Electric Company, d/b/a Ameren Missouri filed its 2015 Renewable Energy Standard Compliance Report and 2016-2018 Renewable Energy Standard Compliance Plan, as required by Commission Rule 4 CSR 240-20.100(8). That regulation requires Staff to file reports about the compliance report and plan, and offers other interested persons or entities an opportunity to file comments. Staff filed its report regarding Ameren Missouri's 2016-2018 RES Compliance Plan on May 27, and filed its report regarding Ameren Missouri's 2015 RES Compliance Report on June 24.<sup>1</sup> Renew Missouri filed comments regarding both the Compliance Plan and the Compliance Report on May 27.<sup>2</sup> United for Missouri filed comments regarding the Compliance Plan on May 28.

Commission Rule 4 CSR 240-20.100(8)(F) allows the Commission to direct Ameren Missouri to provide additional information or to address any concerns or deficiencies identified by Staff or any other commenter. Before deciding whether any

additional information is required or whether any concerns or deficiencies need to be addressed, the Commission will establish a time for the filing of responses to Staff's reports and Renew Missouri's, United for Missouri's, and Division of Energy's comments.

**THE COMMISSION ORDERS THAT:**

1. Any person or entity wishing to respond to Staff's Report on Ameren Missouri's 2015 Renewable Energy Standard Compliance Report, to Staff's Report on Ameren Missouri's 2016-2018 Renewable Energy Standard Compliance Plan, or to the Comments of Renew Missouri, United for Missouri, or Division of Energy, shall do so no later than July 8, 2016.
2. This order shall be effective when issued.
