On November 17, 2016, the Commission issued its Report and Order Approving Territorial Agreement, approving the agreement between Union Electric Company d/b/a Ameren Missouri and Platte-Clay Electric Cooperative. On April 7, 2017, Ameren Missouri filed a tariff revision to comply with the terms of the order. The tariff sheets have an effective date of May 7, 2017.

The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation with regard to the compliance filing. Additionally, any other party wishing to respond to the tariff filing shall do so as set out below.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a recommendation with regard to the tariff filing no later than April 20, 2017.
2. Any other party wishing to respond to the tariff filing shall do so no later than April 20, 2017.

3. This order shall be effective when issued.
