ORDER DIRECTING FILING OF PROPOSED PROCEDURAL SCHEDULE

On June 7, 2017, the Missouri Public Service Commission issued an order providing Roger Pritchett an opportunity to show cause why his application for a change of electric supplier should not be dismissed for his failure to appear at a scheduled procedural conference. On June 8, 2017, Mr. Pritchett sent an email to the Commission explaining that he called a contact number for the Commission prior to the procedural conference and spoke to someone, which resulted in his mistaken understanding that he did not need to attend the procedural conference. The email states that Mr. Pritchett wishes to pursue his case to change his electric supplier.

Based on Mr. Pritchett's email, the Commission concludes that Mr. Pritchett has demonstrated good cause for failing to appear at the procedural conference, so the case will not be dismissed at this time. The Commission cautions Mr. Pritchett that the Commission's Staff are not authorized to provide legal advice or guidance to him, so if he desires legal assistance in the future he should contact a private attorney.

The Commission will direct Staff to file a joint proposed procedural schedule on behalf of all the parties.

THE COMMISSION ORDERS THAT:

- 1. The Commission's Staff shall file a joint proposed procedural schedule no later than June 19, 2017.
 - 2. This order shall be effective when issued.
